## 11 NORTHERN TERRITORY LANDCARE PROJECTS FUNDED

### Great News for CLMA

*As you may have heard around the traps, CLMA has recently been awarded funds for 2 major projects happening in central Australia.*

#### **Weed management in the Sandover River catchment**

This project will develop a catchment weed management plan, carry out on-ground weed control work (to control Parkinsonia and Rubberbush) and develop a weeds education and communication program on both Aboriginal and pastoral land in the Sandover region.

For this project we will receive a total of \$157,600. This money will:

- Employ a project manager for 12 months
- Employ a Technical officer for 6 months
- Assist with CDEP top-up and chemical costs for weed control on Utopia
- Provide funds to cover running costs of vehicles, Quad bikes and spray gear on Stations.

- Provide funds to cover administrative and mapping costs

#### **Sustainable grazing land management (GLM) in central Australia**

This project will develop a customized GLM training package for central Australia. Supported by MLA, this package will compliment existing research projects and get real answers and information to producers in the Alice region with regard to land management issues.

For this project we will receive a total of \$92,000. This money will:

- Employ a Course Development Facilitator for 12 months
- Cover fuel, vehicle & computer lease costs, plus admin and printing.
